Survey Methodology

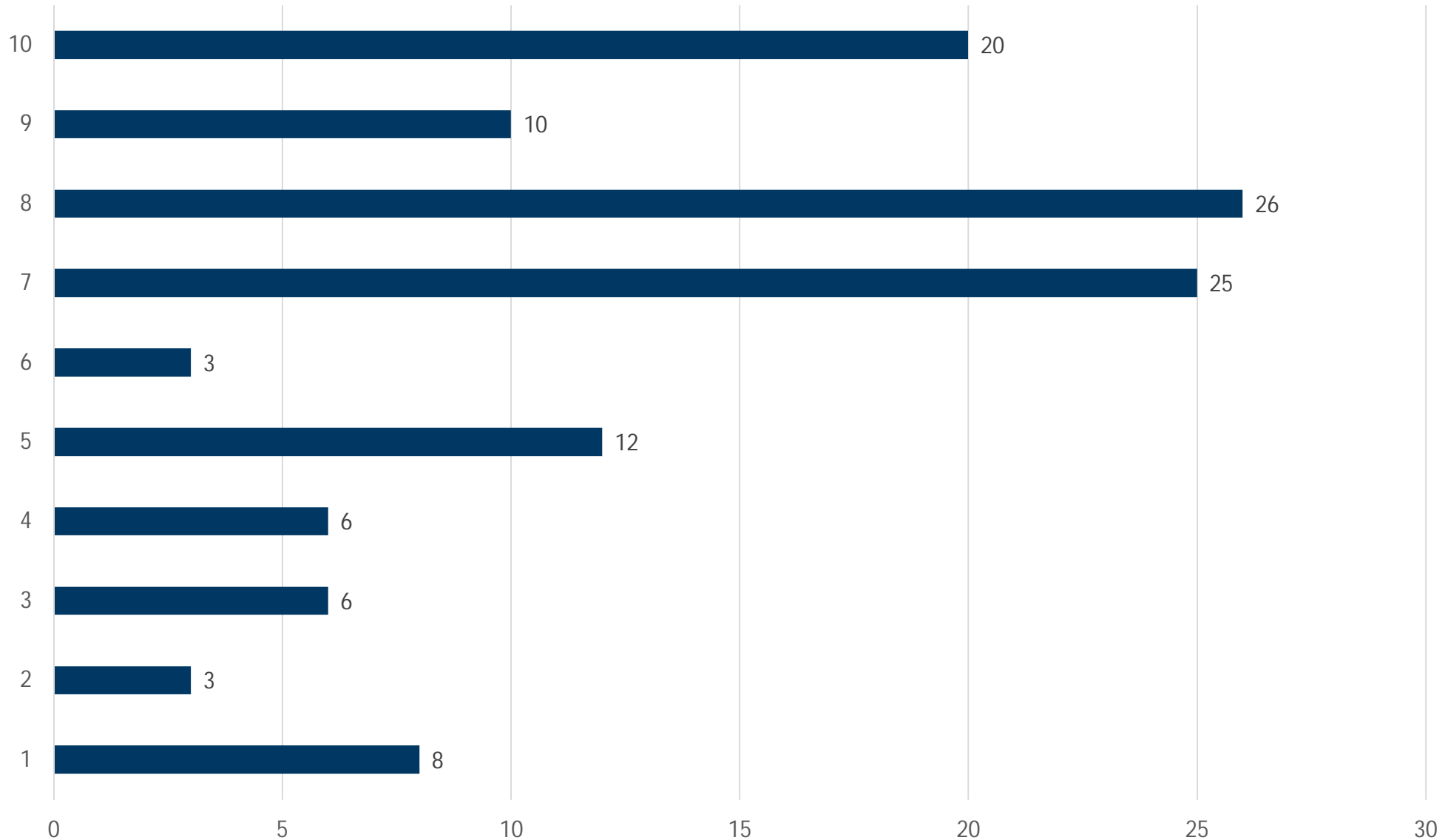
The qualitative survey was prepared with questions generated through discussions among ECHDC, Trowbridge Wolf Michaels Landscape Architects, The Olin Studio, and Bergmann. An 11-question survey was created using SurveyMonkey, and a link was posted to www.buffalowaterfront.com on Thursday, May 2, 2019. The online survey was open through Friday, June 7, 2019. Over the five weeks, 124 responses were submitted to ECHDC.

A 10-question survey was also available at the Open House held at the Burchfield Penney Art Gallery on Thursday, May 2, 2019. Thirty-eight surveys were completed during the Open House. Respondents had the opportunity to provide additional notes on the paper surveys prior to submission.

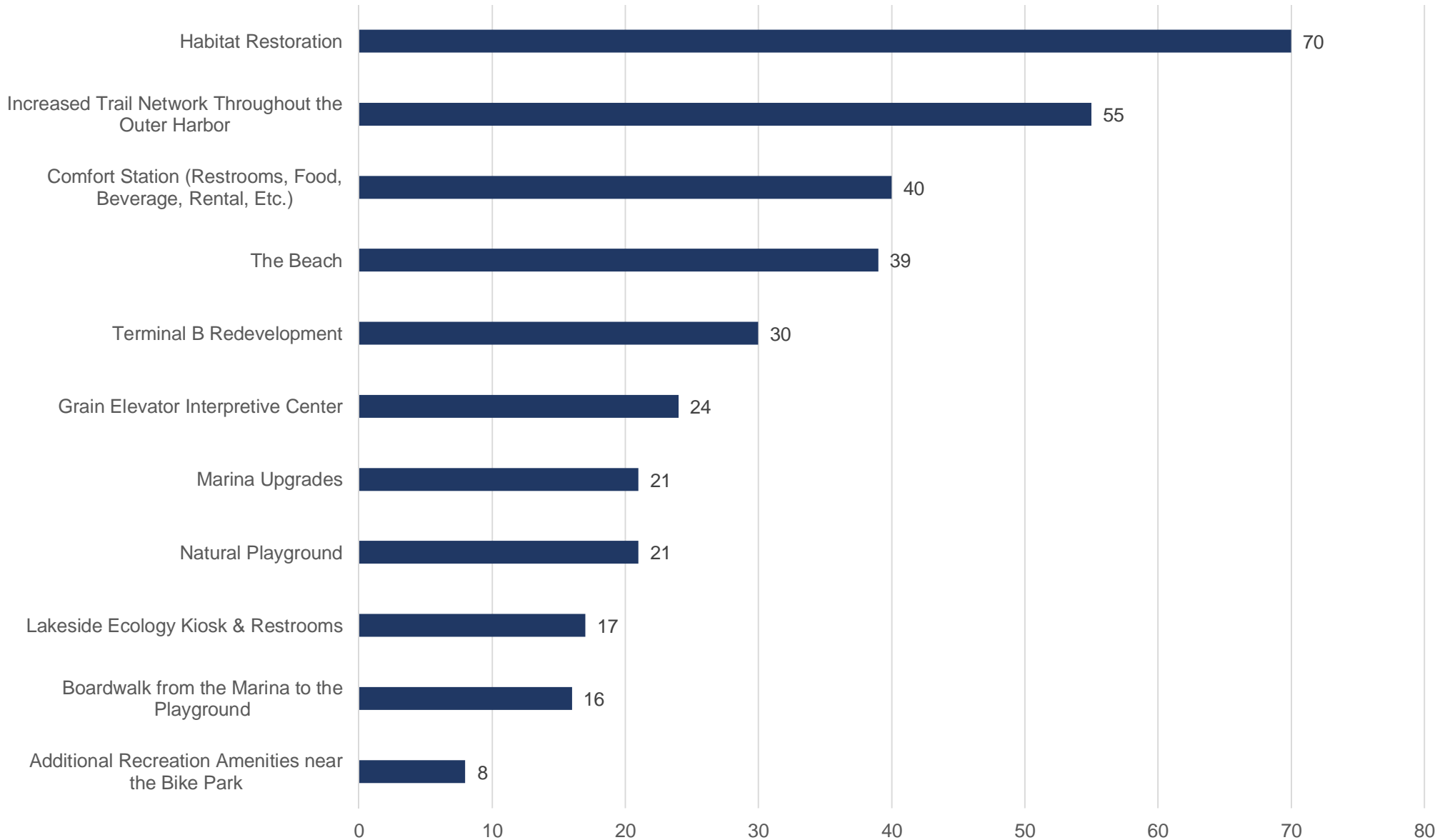
The survey was comprised of three questions related to demographics, two questions related to general feedback about the success of the process, and the remaining five questions solicited public input on the most and least important aspects of the Outer Harbor projects as a whole. The additional online question solicited feedback for open-ended response.

The survey did not require responses to each of the questions, except for one question requiring response due to the logistics of the format. The following results for the demographic and multiple-choice questions show all responses received. Common responses to the fill-in question were extracted to show trends of the collected data.

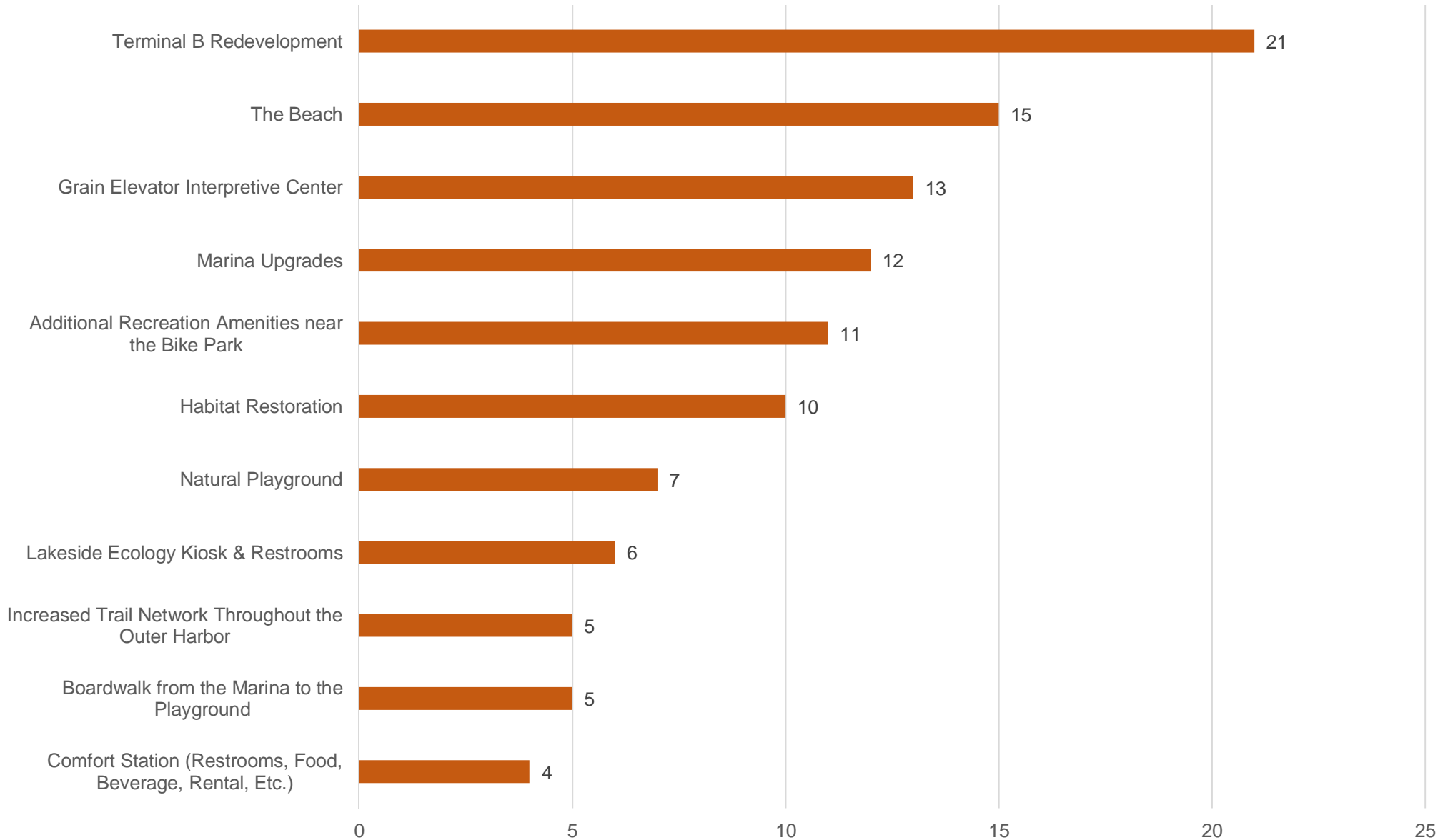
1. On a scale of 1-10 (10 being highest) how do you rate the overall Outer Harbor Preferred Plan?



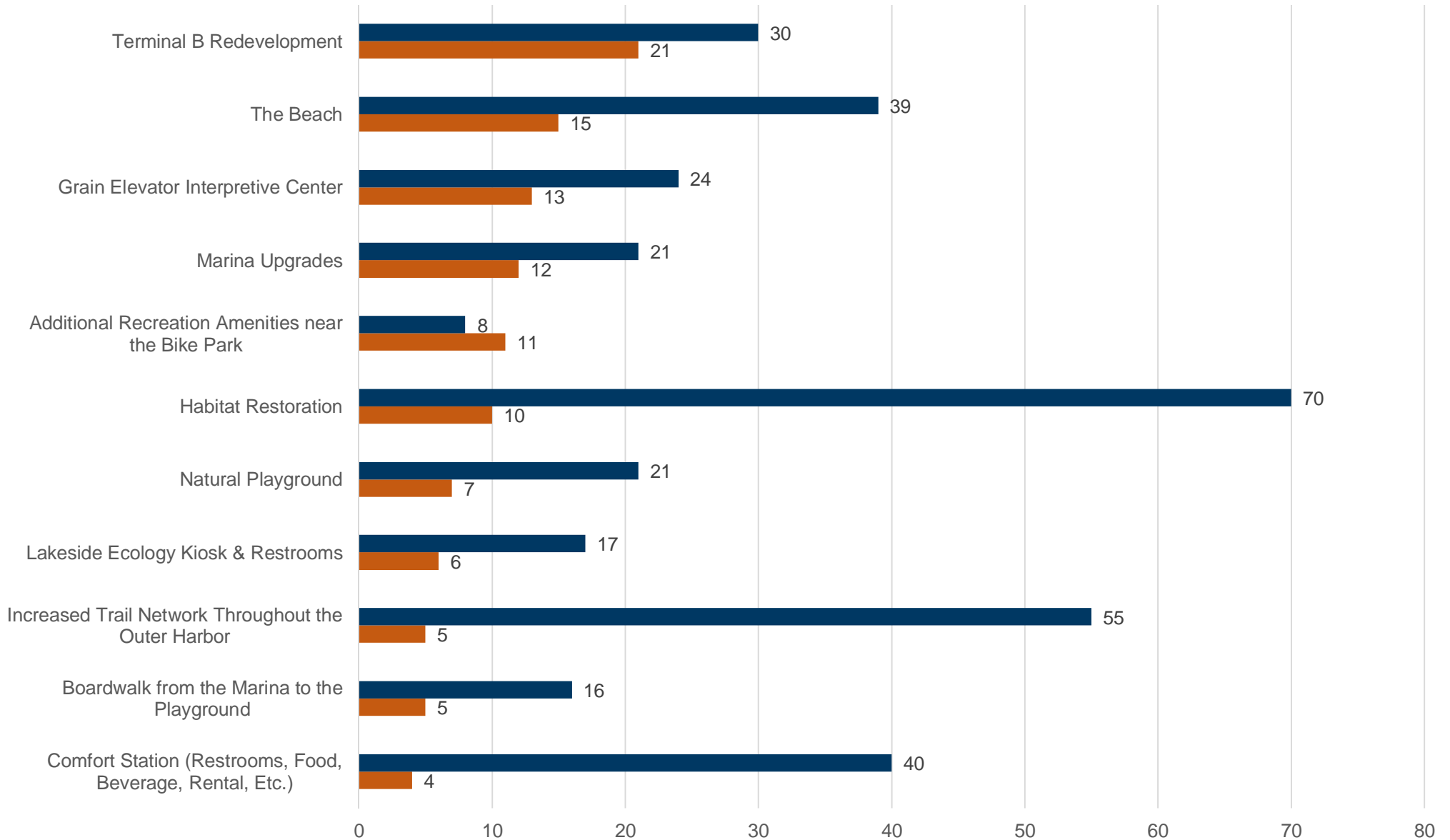
2. My three (3) favorite elements are:



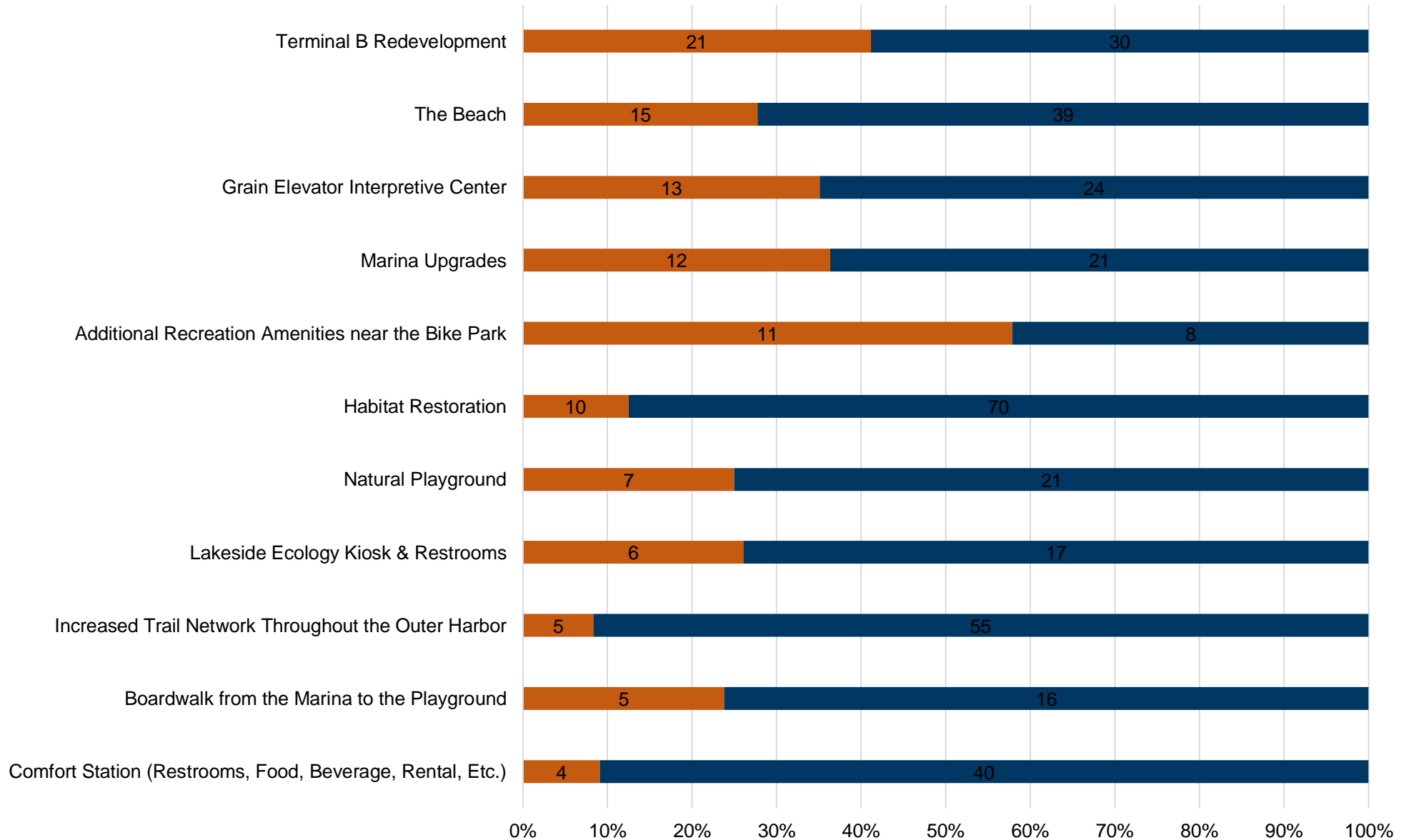
3. If I could remove one (1) element, it would be:



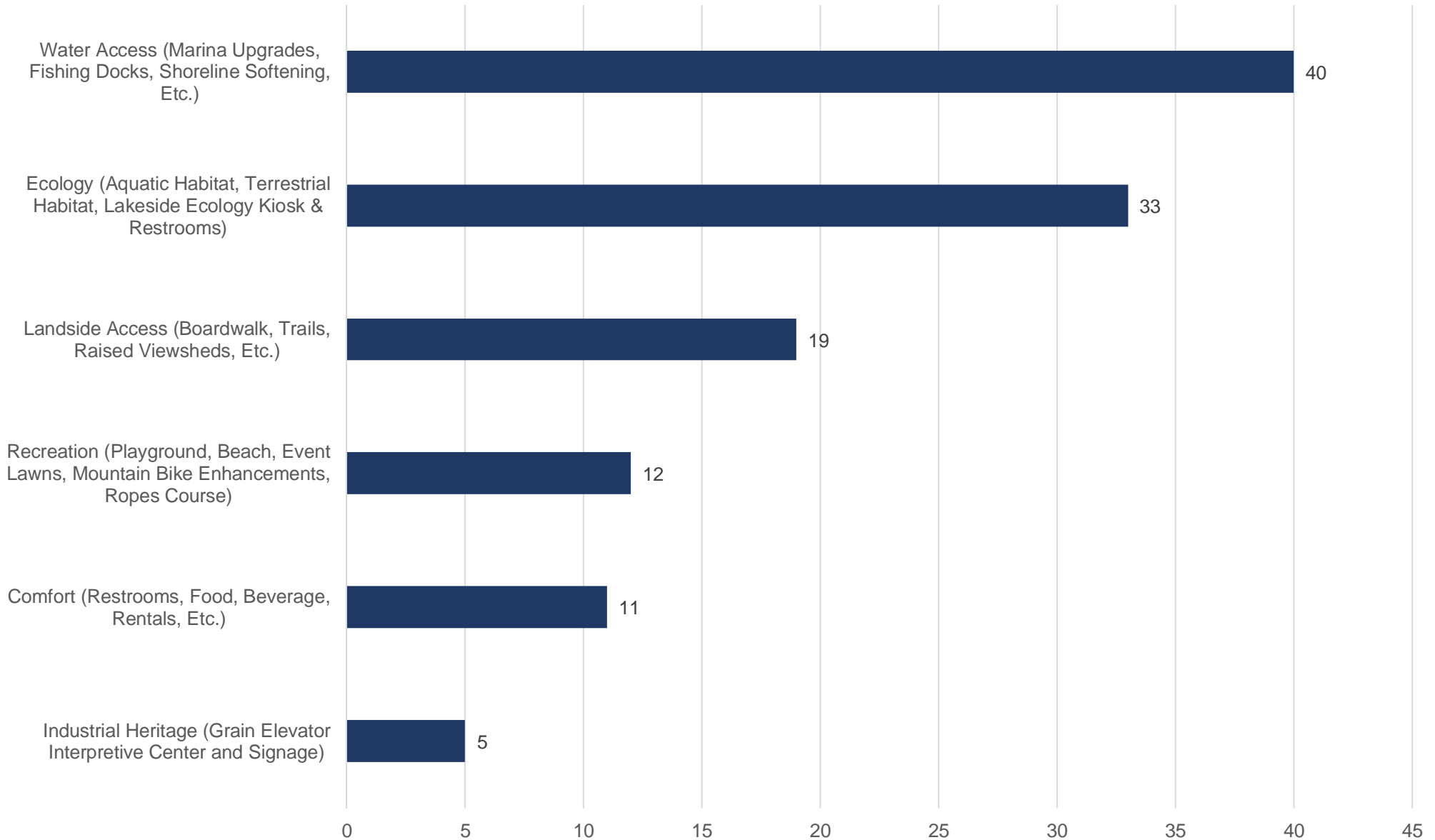

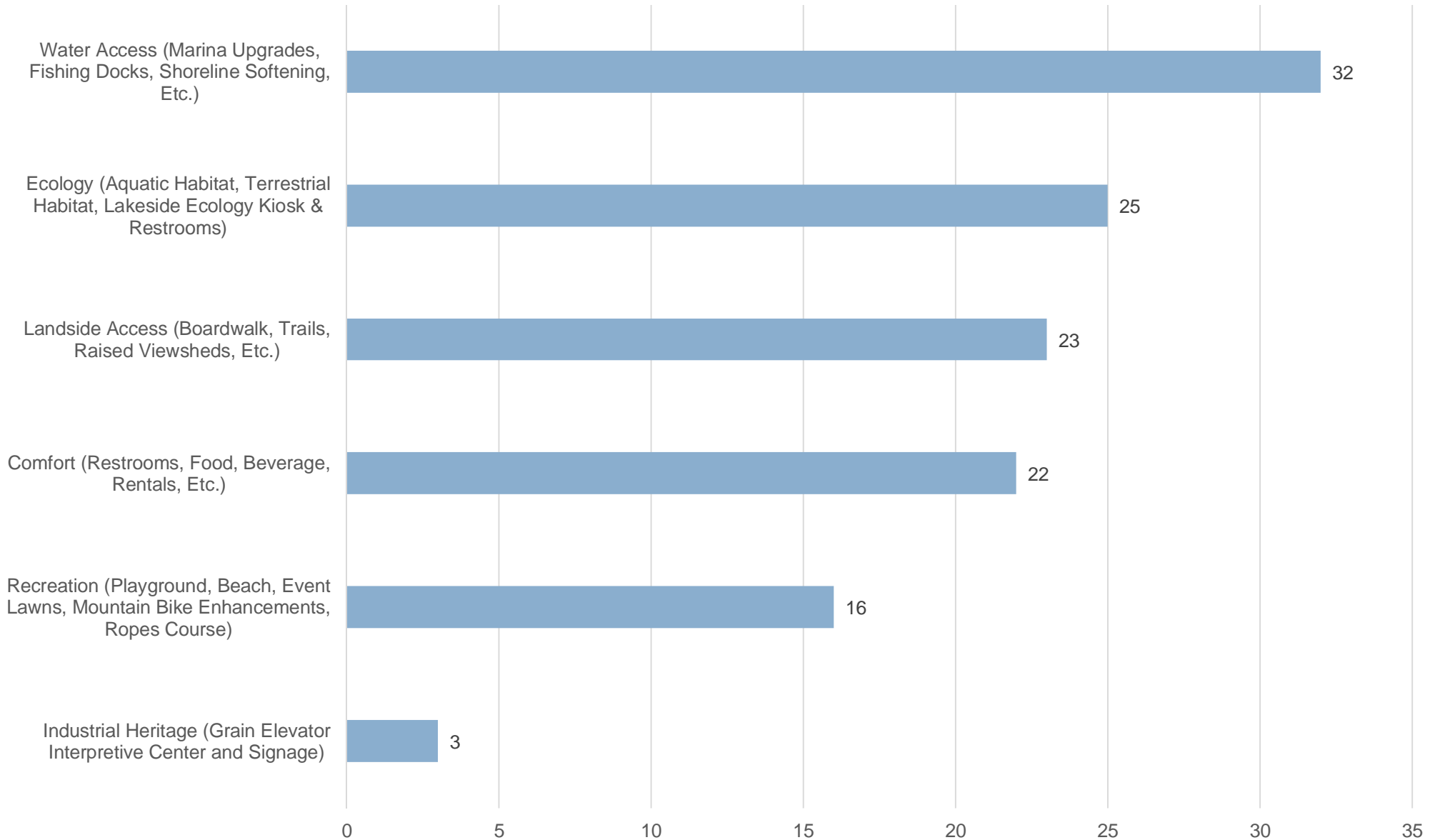
Questions 2 & 3 Compiled Results (by percentage)



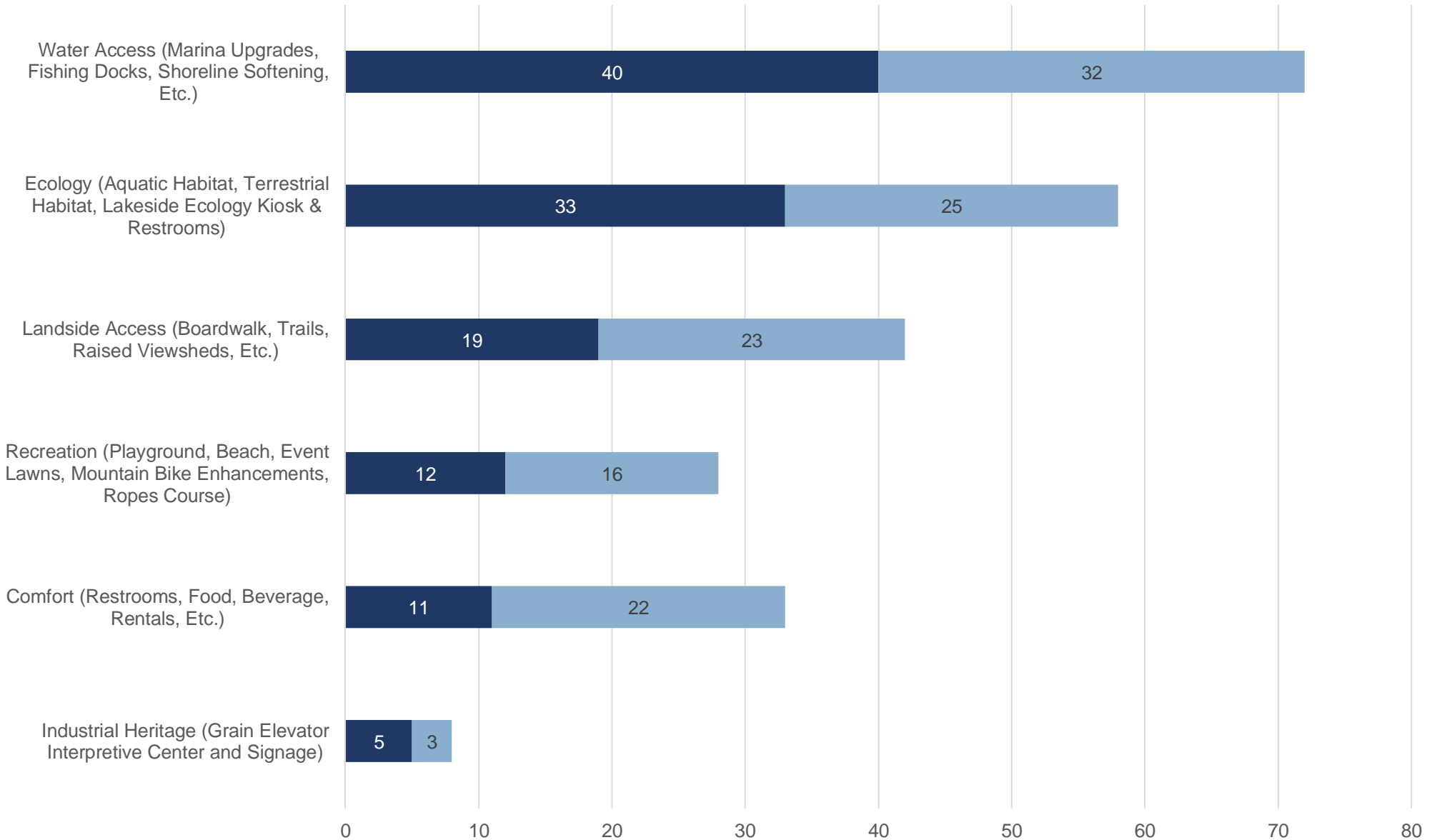
4. If the ECHDC had to focus on *one (1) category* in the next phase of the Outer Harbor, which category would you prefer they invest?



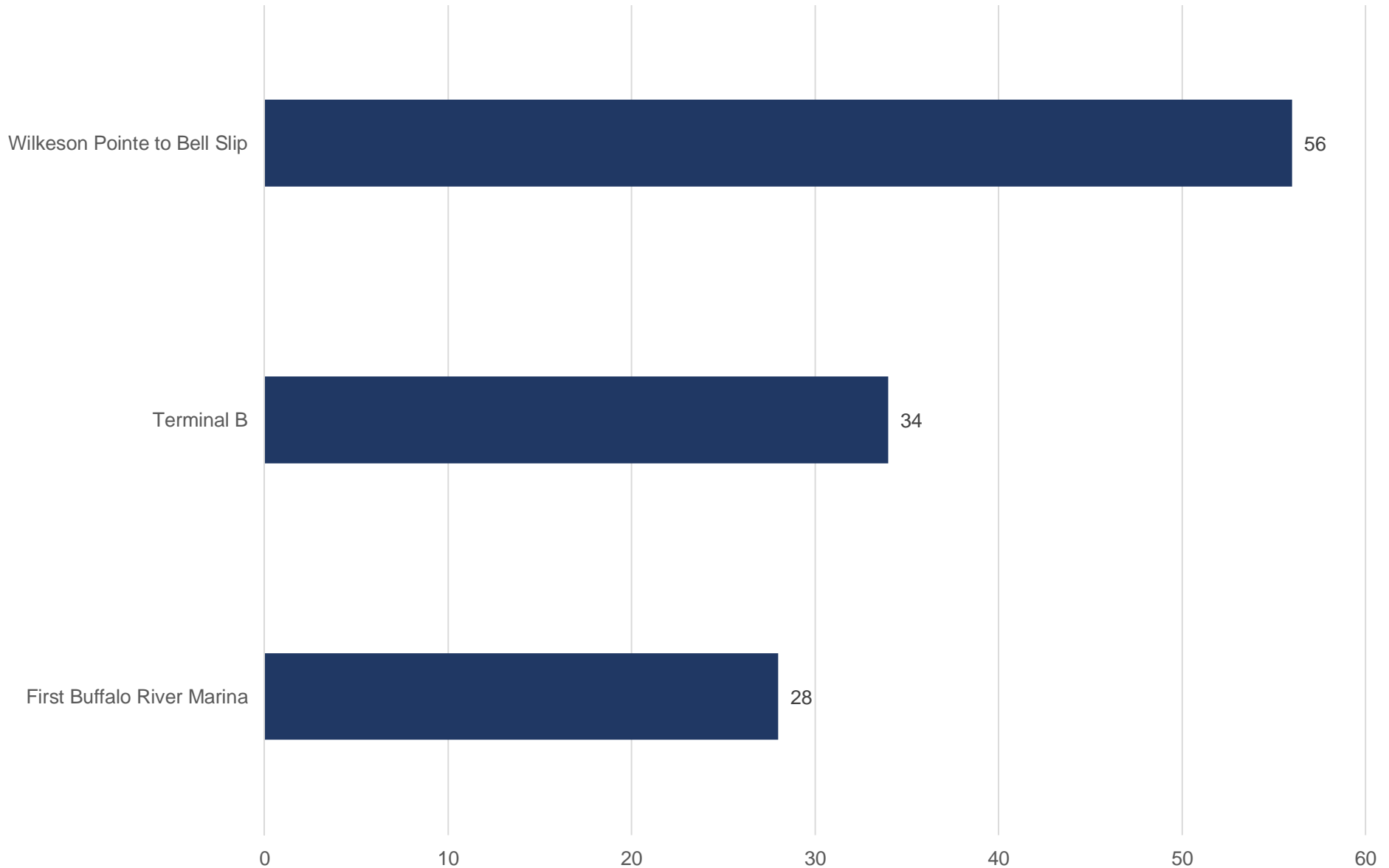
5. If the ECHDC had to focus on *a second category* in the next phase of the Outer Harbor, which category would you prefer they invest?



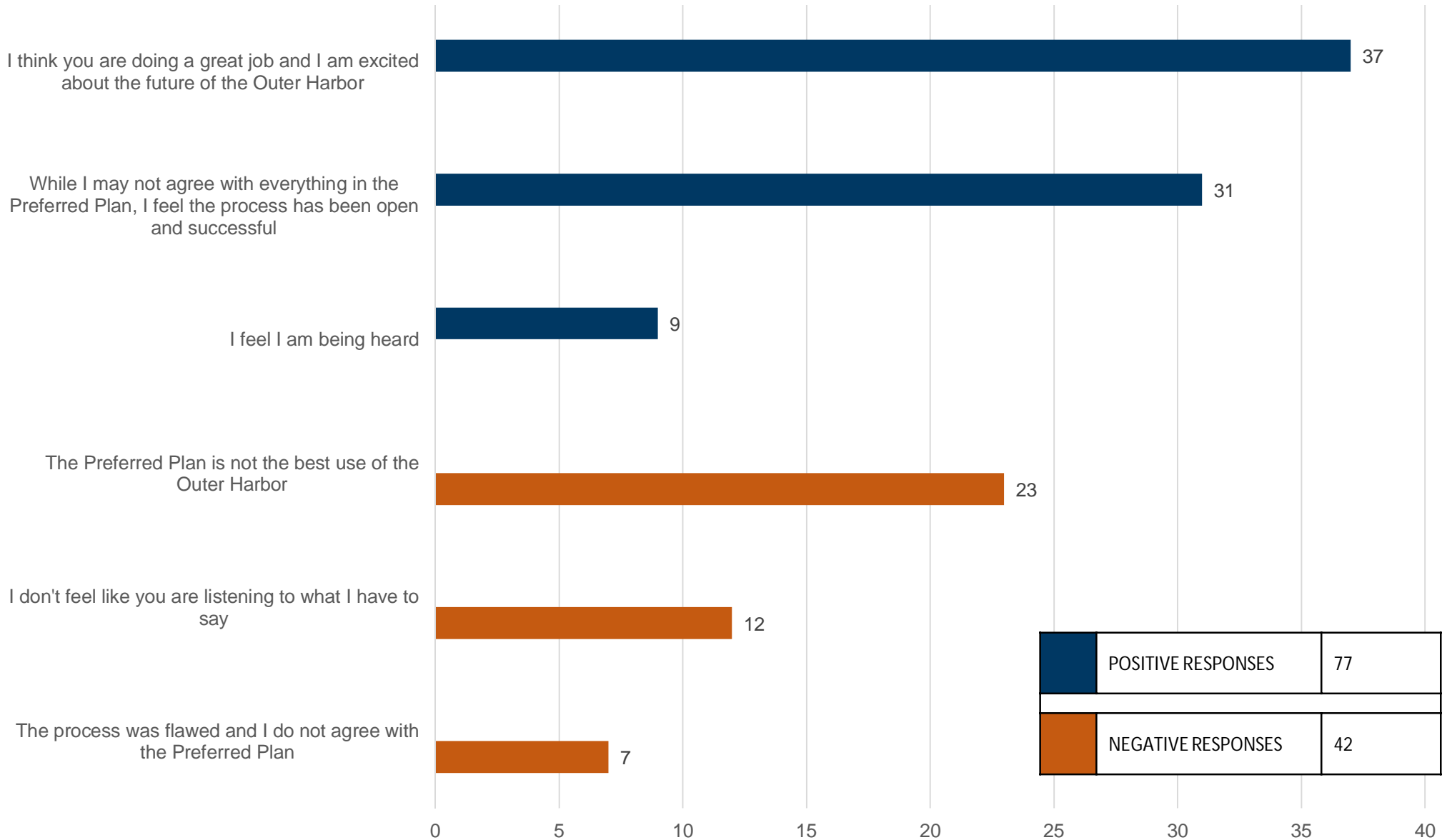

6. If the ECHDC had to focus on *one (1) area* in the next phase of the Outer Harbor, which area would you prefer they invest?

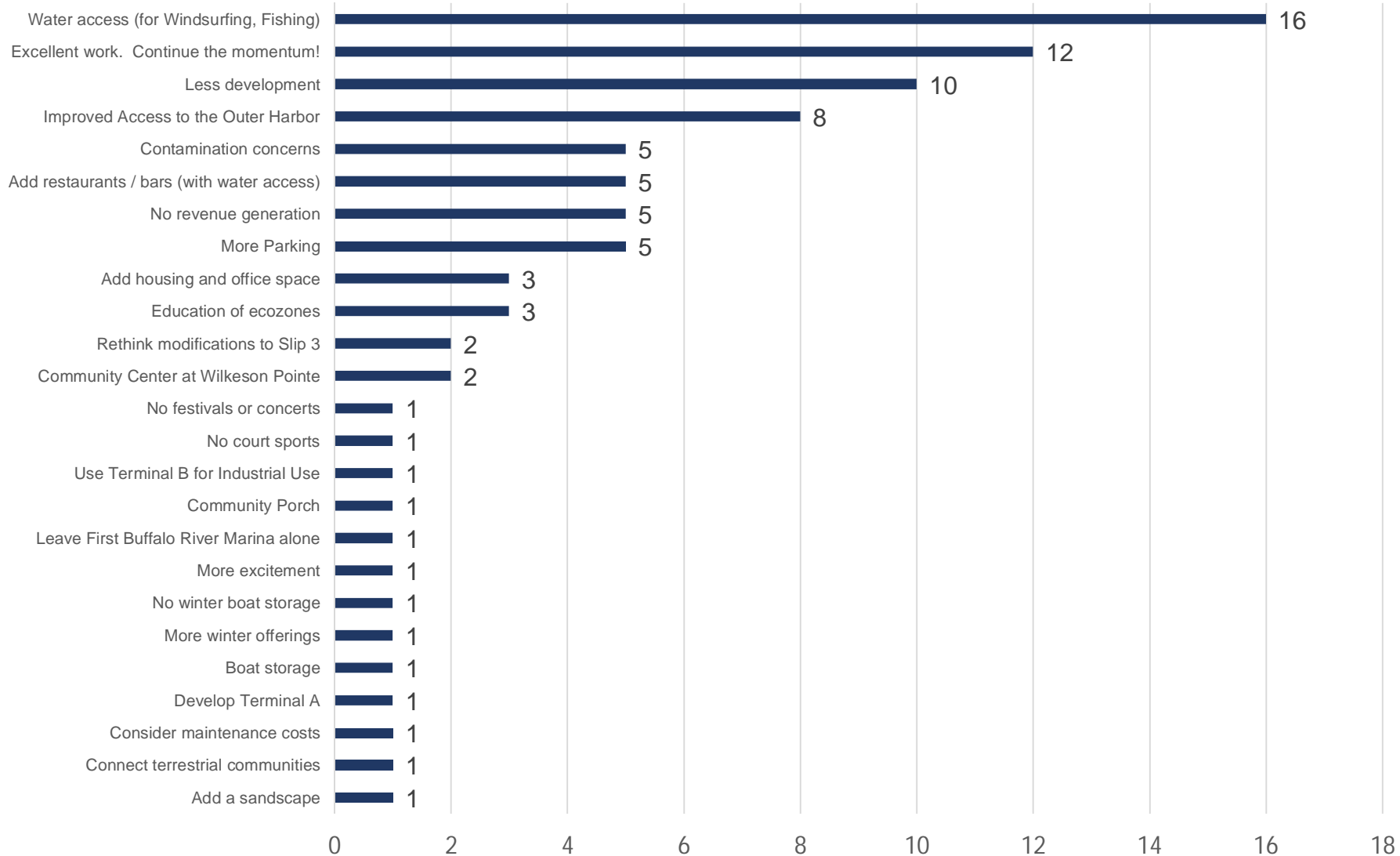


7. Which of the following phrases BEST describes how you feel about the public input process for the Outer Harbor Preferred Plan?

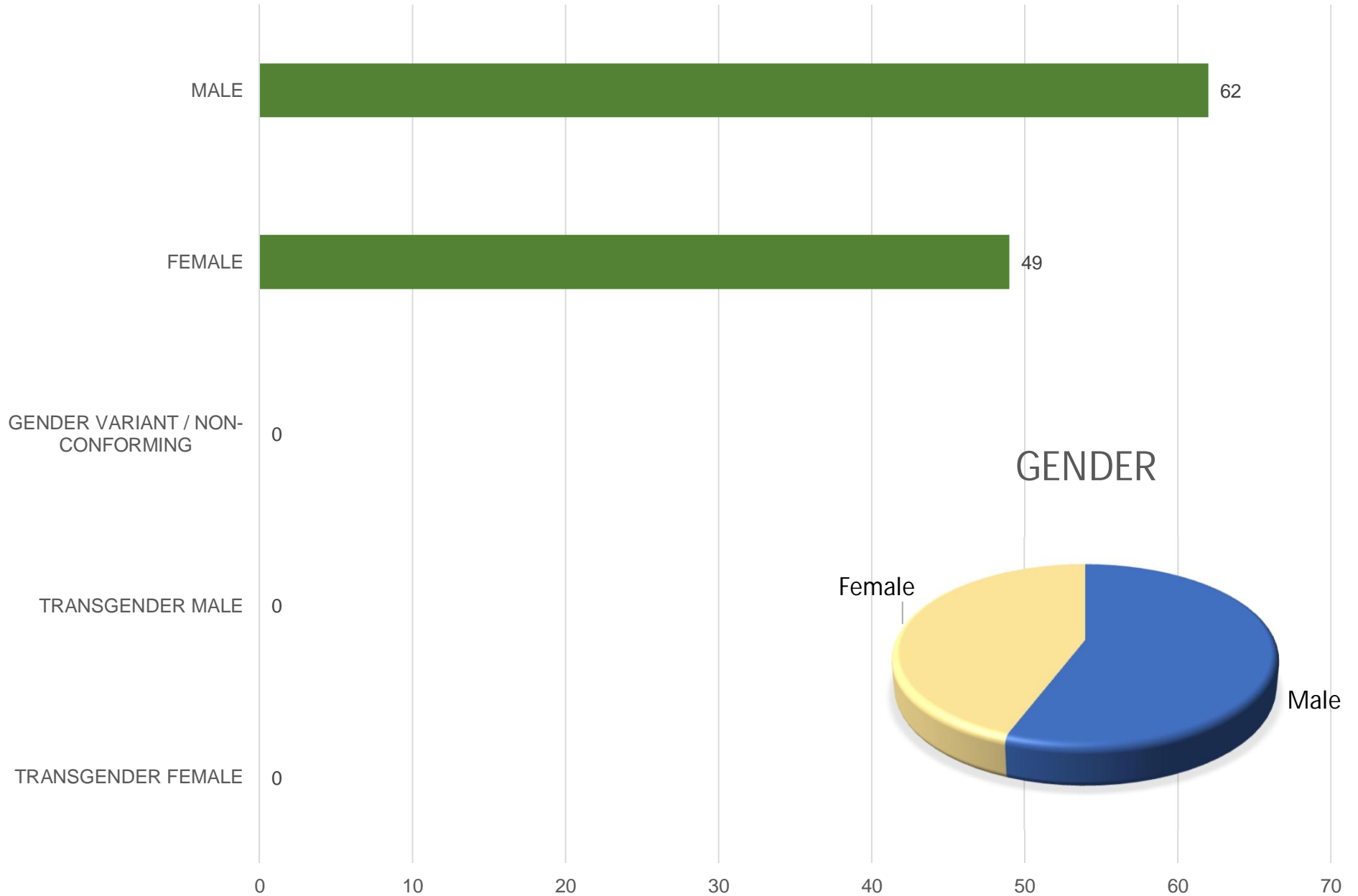

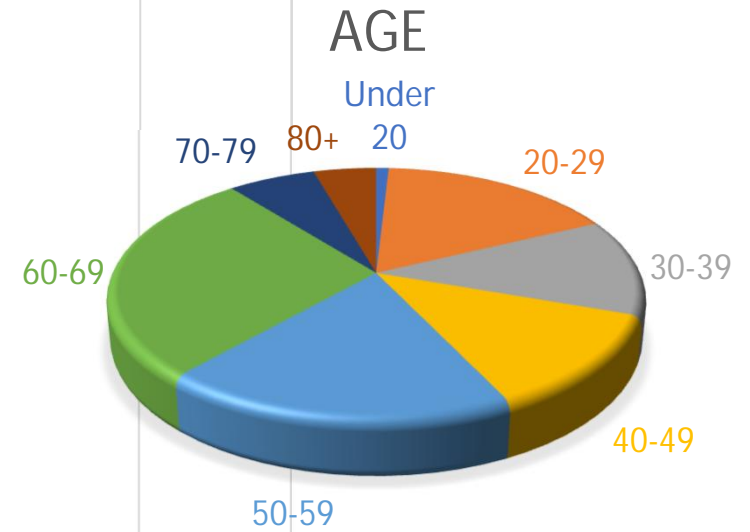
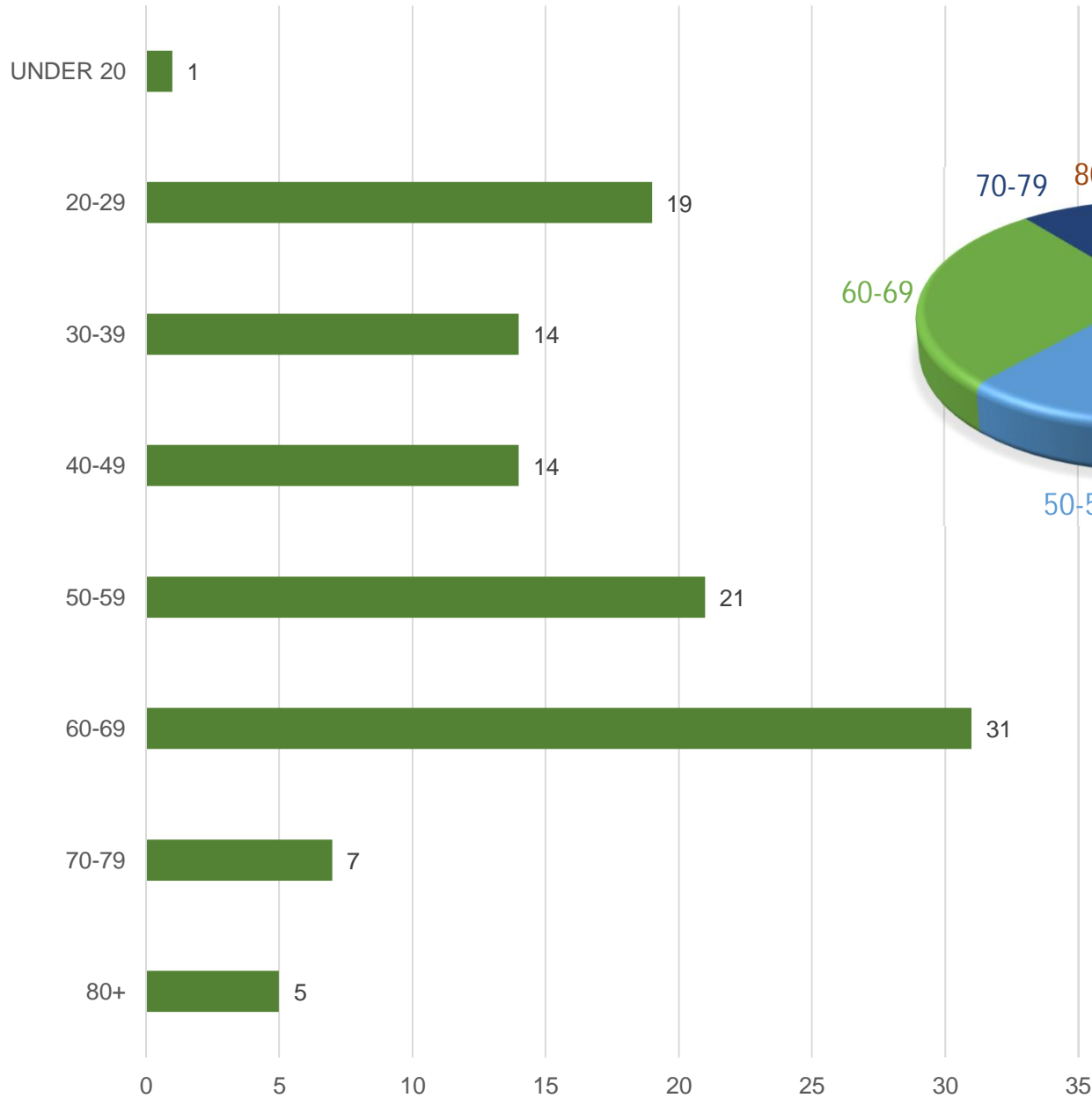
